CHINA G1 LEGALIZATION PROCESS

Updated May 4, 2018

Attached is the form to be used in order for COGENCY GLOBAL INC. to assist with the legalization of document(s) with the Chinese Embassy in Washington, D.C. or any of the Chinese consulates.

To properly complete this form, please read and follow the instructions below carefully.

- 1. The G1 Form must be **TYPED** and all in **CAPITAL LETTERS**.
- 2. Sections 3 and 4 must be filled out with the <u>reason for legalization</u>. Also, Section 4 must state <u>where in China</u> this document is to be used in. It cannot be left blank.
- 3. An individual from the company (Officer, Director, or Counsel) must sign the G1 Form and it must be submitted with a photocopy of that individual's passport or driver's license. If the driver's license is provided, insert the nationality of the individual on the side of the G1 Form.
- 4. Section 7 must have COGENCY GLOBAL listed as the agent. We (COGENCY GLOBAL) will execute our portion of the Agent Section in #8 before submission.
- 5. The <u>original executed G1 Form</u> along with a copy of the driver's license or passport of the individual who has signed the G1 must be sent to the COGENCY GLOBAL office you are working with.
