# CORPORATE/ENTITY NAMES IN NEW YORK STATE: WORDS THAT MAY RAISE A "RED FLAG"

When forming business and not-for-profit entities or filing Assumed Name Certificates in New York State, certain words may cause problems or delays in getting your document filed. Bear in mind that names containing these words may be "available" and can easily be reserved - however, when it comes time to file the documents, in most cases, they will be rejected by the NY Department of State unless prior approval has been received by the appropriate state department (i.e. Banking, Insurance, etc...). In many cases, abbreviations or derivations of the words set forth below will also cause rejection. The final decision is in the hands of the filing officer.

\*"Pharmacy" used in connection with a retail establishment is acceptable whereas "pharmacist" implies a professional. \*"Radiology" is a medical specialty and implies a professional. "Radiology" technician is acceptable provided it is stated in the filing document that professionals will not be employed and diagnoses will not be made.
